Endorsement wording

The following is a **condition precedent**. Prior to releasing **contractors' plant** out on hire to non-account customers and/or first time hirers and/or private retail customers you must undertake the following procedures;

- a) Copy taken of customers proof of title and address and/or;
- b) Check customers signature matches with the debit/credit card and/or;
- c) Telephone call made to customers employer to confirm identity

In addition to the above you must take a copy of the hirers valid identification card, passport or driving licence and seek confirmation from the hirer they have an appropriate level of insurance cover.

You must also obtain a copy of the hire agreement signed by the hirer for unless the hirer is an account customer whom has previously signed an agreement that the conditions of hire apply for each and every future hire.

All records must be made available to us upon request.

Section 1 - Contractors' plant - owned

Where section 1 is shown as insured in the schedule the following cover revision applies.

In 'How much we will pay' the references to **contractors' plant** 'two years old or less' and **contractors' plant** 'over two years old' are changed to 'three years old or less' and 'over three years old' respectively.

Extra cover applying to multiple sections

The following 'Extra cover' is added:

Fuel tank drainage

We will pay for the draining of any fuel tanks forming part of or attached to **insured property** following incorrect fuelling and any resultant **damage** to **insured property**. The most we will pay for each occurrence is GBP 2,500.

Hire charges for substitute equipment

In addition to Extra cover 2 – Hire of substitute contractors' plant under Section 2 – Contractors' plant – owned, if we accept a claim for **damage** to **insured property**, we will pay:

- the cost of hiring substitute equipment of a similar type and capacity while the **damaged insured property** is being repaired, or until the **damaged** insured property is permanently replaced. The most we will pay for each **occurrence** is GBP 10,000; and
- your liability under the hire agreement for **damage** to the substitute equipment provided that the hire is under the standard conditions of the Construction Plant-hire Association, Scottish Plant Owners Association or Hire Association Europe which are current at the time of the hire. The most we will pay for each occurrence is GBP 50,000.

Own surrounding property

We will pay for **damage** to own surrounding property as a result of accident/error or fault of lifting plant insured under sections 2 or 3 of this policy. The most we will pay for each **occurrence** is GBP 25,000.

Security devices

We will pay for **damage** to any approved security devices as a result of any attempted theft or malicious **damage** to **insured property**. The general exclusion 'Excess' will not apply to this extra cover. The most we will pay for each **occurrence** is GBP 5.000.

Signwriting or livery

We will pay for **damage** to own or hired properties' signwriting or livery following **damage** covered elsewhere under this policy. The most we will pay for each occurrence is GBP 5,000.

Transportation of damaged contractors' plant

If we accept a claim for **damage** to **contractors' plant** we will pay for the necessary and reasonable cost incurred by you in the protection, removal and transportation of the **damaged contractors' plant** to and from a location agreed by us for the purposes of repair. The most we will pay for each **occurrence** is GBP 25,000.
